Client makes the following representations about their Dog:

- ☐ The undersigned represents all the owners of the Dog.
- ☐ Dog MUST Be vaccinated against rabies and it must be current. You MUST provide printed copy of current Rabies vaccination certificate when dog is dropped off. DHPP and Parvo vaccinations optional for adult dogs if they received vaccines as a puppy. If you got the dog as an adult and you don't know it's history of vaccinations, the dog must get DHPP and Parvo vaccinations. All puppies must be vaccinated for DHPP and Parvo (under 12months).
- ☐ Dog is in good health.
- ☐ Dog is friendly toward children and adults if not, you must notify me, otherwise your boarding contract will be terminated with no refund. I can provide 4 weeks Advanced Obedience Board and Training for an additional price to resolve these issues.
- ☐ Dog is friendly toward other dogs and other animals you must notify me if there are any issues so I can properly handle your dog. If your dog has issues, they will not be socialized but will be allowed 4x per day 15 minutes outside in the fenced area. If you want me to socialize your dog with other dogs the extra charge is \$100/day. Or I can provide 4 weeks Advanced Obedience Board and Training that can start the day you drop off, and the boarding is included in the Board and Train Costs.
- ☐ Dog has never bitten a person. If your dog has bitten a person, you must describe the situation and I will decide if I accept your dog for boarding or not. Ask me about pricing for training your dog needs to learn to be friendly toward people.
- ☐ Dog has never escaped or ran away. If so, you must notify me and explain the circumstances.
- ☐ Dog has not had heat exhaustion in the past.

- ☐ Dog has never been declared as dangerous or aggressive.
- ☐ Dog MUST be on flea, tick preventative, and heartworm medication.

IMPORTANT: A printed paper copy of your dog's current Rabies Vaccination Certificate must be provided at the time of drop-off. Dogs without a current paper copy of their rabies vaccination record cannot be admitted for boarding.

Elena's K-9 Expectations and Responsibilities:

_____ ["Owner"] hereby retain Elena's K-9 to board
_____ [the "Dog(s)"] under the following terms and conditions:

Boarding Services

During your dog's stay, Elena's K-9 Advanced Obedience Dog Boarding will provide reasonable care including feeding according to your instructions, fresh water, supervised exercise and potty breaks, safe housing, medication administration (if provided), and general supervision.

Owner Responsibilities

Owner shall provide sufficient food for the entire stay plus two extra days, all medications in original containers with written instructions, and an emergency contact.

Veterinary Care Authorization

If emergency veterinary care is required and the Owner cannot be reached, the Boarding Facility is authorized to obtain emergency veterinary treatment. All veterinary expenses are the Owner's responsibility.

Personal Property

Beds, blankets, toys, bowls, collars, and other personal items are accepted at the Owner's risk. The Boarding Facility is not responsible for loss or damage.

Boarding Fees

Boarding Fee: \$ 45 per day. If there are behavioral issues, the price can vary, this will be discussed in person.

Payment Due at drop off.

Late Pick-Up

Additional boarding charges may apply for late pickup or failure to pick up as scheduled. If I am not notified at least 3 hours prior, and pick up is late, there will be an additional fee charged.

Abandonment

If the dog is not picked up and no communication is received for more than seven (7) days after the scheduled pickup date, the Boarding Facility may make reasonable efforts to rehome the dog or transfer

it to a rescue organization. Boarding charges and other expenses remain the Owner's responsibility to the extent permitted by law.

Photo & Video Release

Owner grants permission for photographs and videos of the dog to be used for advertising, educational, and promotional purposes unless revoked in writing.

Termination

The Boarding Facility reserves the right to refuse or terminate boarding if a dog presents a danger to people or other animals, has a contagious illness, or if the Owner violates this Agreement.

Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes prior oral discussions relating to this boarding stay.

Liability Waiver

The Owner understands that boarding animals involves inherent risks including illness, injury, stress, escape, or interactions with other animals. The Boarding Facility will exercise reasonable care but is not responsible for events beyond its reasonable control. The Owner remains responsible for damage or injury caused by their dog and agrees to indemnify the Boarding Facility against resulting claims. The client is at all times responsible for the actions of their dog. Elena's K-9 is not responsible for any injuries or expenses resulting from boarding. Elena's K-9 is not responsible for any self-inflicted injuries incurred by dog. Dogs participating in physical exercises may be injured by running, jumping, chasing a ball, around other dogs, around other humans etc. Client hereby indemnifies and holds harmless Elena's K-9. Elena's K-9 will take all reasonable and necessary precautions during boarding.

Client's Assumption of Risk: Client acknowledges that training Location, and the animals, guests, items and activities there on, pose dangers to people and animals. Such dangers include, by way of example and not limitation: (a) animals that are difficult to control and that may bite, trip, knock down, collide, or fight; (b) natural and man-made hazards (e.g., wildlife, equipment, slippery surfaces, or trip hazards) that may exist on training; (c) hazards associated with travel to and from training; and (d) injury or death of the Dog. Accordingly, Client, on behalf of him/her, his/her family, guests and invitees, assumes the risk of injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses of every possible cause and description. If Dog is injured or dies in a dog fight or an accident, gets fleas, ticks or worms, contracts any illness or disease, is lost or stolen, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this Agreement, on or off training Location, Client accepts the risk of the same and agrees that trainer shall not be held responsible for it or any resulting injuries, illnesses, losses, damages, costs or expenses whatsoever.

Client's Liability: If Client, its family, guests or invitees, or the Dog causes property damage, or bites or injures any dog, animal or person during or after the term of this Agreement, on or off Premises, then Client agrees to pay all resulting losses and damages suffered or incurred by Elena's K-9, and to defend and indemnify Elena's K-9 from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney's fees.

Termination: At Elena's K-9 sole election, Elena's K-9 duties hereunder shall terminate if (a) in Elena's K-9 sole judgment Dog is dangerous or vicious to any person or animal or interferes with the boarding of other dogs; or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Elena's K-9 duties shall terminate but all other provisions of this Agreement shall continue in full force and effect. No refunds will be given for boarding under such

circumstances. Notwithstanding the foregoing, Elena's K-9 reserves the right to refuse to provide goods and/or services to Client, at any time and from time to time, at its sole discretion.

CLIENT HAS READ, UNDERSTANDS, AND AGREES TO ALL TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT.
